USCG Change in Regulations

USCG has stipulated that as of **26 February 2016** all commercial vessels sailing in US coastal waters must have an approved survival craft onboard that ensures no part of an individual is immersed in water.

This means that basic life floats and similar systems must be phased out and replaced by approved craft in order for the vessel to meet the new requirement.
